## PROGRAM DESCRIPTION

The Multiple Subject Preliminary Credential Program is offered in a variety of formats called “blocks” including traditional full-time blocks over two semesters, a seven-month accelerated block (Spring only), and a three or four semester block. Full-time student teaching is required of all candidates according to state law. Our programs combine coursework and student teaching to link theory and practice. Approximately 50% of the total program is devoted to student teaching.

The curriculum emphasizes the preparation of reflective practitioners to meet the needs of culturally and linguistically diverse children. Most blocks are based at local elementary schools where we have established partnerships with schools and teachers. In these blocks, student teachers may take their university coursework on-site at the elementary school and student teach at that school or in neighboring schools. Each student completes student teaching in two different grade levels; one assignment is at the primary level (grades K-3) and another is at the intermediate level (grades 4-6).

All students enrolled in the Multiple Subject Teacher Preparation Program will take the following courses. The scheduling and sequence of the courses vary with individual block offerings.

Credential candidates must maintain a 3.0 cumulative grade point average in all professional education coursework attempted in order to continue enrollment in the credential program and to be recommended for the credential. A minimum grade of credit, “C” or better is required in each individual class. Students who do not meet these standards will not be allowed to progress until deficiencies have been remediated.

APPLYING TO SDSU SCHOOL OF TEACHER EDUCATION IS A TWO-STEP PROCESS:

- Step 1: Apply to SDSU for graduate admission
- Step 2: Apply to the Department

**Step 1: Graduate/Post-baccalaureate Application:** For admission to SDSU, a CSU Graduate/Post-baccalaureate Application and appropriate fee must be submitted to the university. This application may be completed online at [www.csumentor.edu](http://www.csumentor.edu) SDSU undergraduate students who will be graduating with their bachelor's degree must re-apply to the university for Graduate/Post-baccalaureate standing. **You MUST submit the university application prior to submitting the Multiple Subject Teacher Credential program (departmental) application. Departmental applications cannot be processed unless this university application has been completed first.** There is a \$55 application-processing fee for the university application.

**Applicants for Prerequisites Only:**

If applying for prerequisite courses only, one complete set of official transcripts from **every** college and university attended other than SDSU must be provided as part of the SDSU Graduate/Post-baccalaureate Application. If accepted into the university, you will have a maximum of two semesters as a conditionally classified graduate to complete all prerequisite courses. If you are accepted and do not attend, then you will have to re-apply for admission for any future semesters. Admission for prerequisites is not a guarantee for future departmental admission.

**Transcripts:**

- **You must submit one official transcript from each school you have attended, regardless of how many classes were taken at the institution.**
- This includes community colleges and study abroad programs.
- SDSU graduates do **NOT** need to provide an official transcript for courses taken at SDSU.
- Check your Web Portal account to see which transcripts the university is still requiring

**Previous SDSU students:**

If you have been an SDSU student previously and applied prior to 2007 then you are required to submit your transcripts to SDSU again. SDSU started scanning and storing transcripts in 2007. Anyone admitted prior to 2007 needs to resubmit transcripts. If you have applied since 2007 but did not attend then you may also need to submit transcripts because SDSU only keeps transcripts on file for 1 year if you do not attend. Please check your Web Portal account if you are unsure of which transcripts are needed.

**Completion of a Bachelor's Degree Program:**

- All candidates must have completed or be in the process of completing a bachelor's degree program. Proof of your bachelor's degree is required by an official transcript showing the date of its posting.
- If you are currently completing your bachelor's at the time of application, you will be required to provide an additional transcript, to our office, after your degree has posted.
- If you are completing your bachelor's at SDSU, this information is available to us through Web Portal.

**Grade Point Average:**

Credential Program Candidates must have a grade point average of at least 2.67 overall based on all baccalaureate and post-baccalaureate coursework, or a grade point average of at least 2.75 in the last 60 semester or 90 quarter units attempted for admission to the credential program and San Diego State University. Please consult our Multiple Subject Advisor if you do not meet this GPA standard.

<b>APPLICATION PROCEDURES: DEPARTMENTAL APPLICATION REQUIREMENTS</b>

**Step 2: Application for Admission to the Multiple Subject Program (departmental application):**

1. **Prerequisite Courses:** The following courses must be completed, within the last seven years, with a grade of “C”, credit or better prior to entering the program. These courses cannot be taken concurrently with the program, but may be in progress at the time of application or taken in the summer prior to fall admission into the program. Proof of enrollment is required to be considered for admission. Individuals who are not current SDSU students may apply to SDSU using the graduate application (at [www.csumentor.edu](http://www.csumentor.edu)) to take prerequisites only or may enroll in these courses through Open University with the [College of Extended Studies](#).

- ED 451, “Introduction to Multicultural Education” (3 units)
- MATH 210, “Structure and Concepts of Elementary Mathematics” (3 units)
  - In lieu of Math 210, candidates may substitute any calculus class taken at a college or university within the past seven years with a grade of “C,” credit, or better.
- TE 296 or HHS 280, “Health Education for Teachers” (1 unit)
- SPED 450, “Classroom Adaptations for Special Populations” (2 units) or SPED 500, “Human Exceptionality” (3 units) or CFD 590, “Children with Special Needs” (4 units)

2. **CBEST:** The California Education Code specifies that candidates for a credential to serve in the public schools of California must verify basic skills proficiency in one of three ways:

1) Passing the California Basic Educational Skills Test (CBEST);

- Please plan to take the exam early in the application process.
- To pass the CBEST, you must pass all three sections (Reading, Mathematics, and Writing)
- **Must submit a copy of passing scores on all three sections of the CBEST test BEFORE your application can be reviewed for admittance to the teacher credential program**
- Submit a copy of the official score sheet that you receive in the mail to our office
- Computer versions of the exam will be offered for a one week period each month. Taking the exam this way is more costly (\$105 versus \$41 for paper exam), but you are able to take the exam more frequently. 3. **CSET EXAM:** All applicants for the Multiple Subject Preliminary Credential Program at SDSU are required to pass the CSET: Multiple Subjects Examination to demonstrate subject matter competency.

Subtest I: Reading, Language & Literature, History, Social Science

Subtest II: Science, Mathematics

Subtest III: Physical Education, Human Development, Visual & Performing Arts

- CSET: Multiple Subjects consists of three separate subtests, which are individually scored. You must pass each of the three subtests.
- Please plan to take the exam early in the application process.
- With restrictions, individuals who have taken and not passed all subtests of the CSET may be eligible for the Three Semester program. However, all subtests **must** have been taken and copies of all test scores must be submitted in order to be eligible.
- CSET exam scores are considered valid for five years. Teacher certification must be recommended within that time period in order for the scores to be posted permanently.

- **Must submit a copy of passing scores on all three sections of the CSET test BEFORE your application can be reviewed for admittance to the teacher credential program**

**4. Early Field Experience:** All candidates must successfully complete of a minimum of 30 hours of volunteer or paid observation and participation in a regular, public elementary classroom within the past four years. You may not use tutoring or after school program hours to complete this assignment. The purpose is to get you into a classroom to see what a “day in the life of a teacher” is really about.

- **This requirement must be COMPLETE and may NOT be in progress when you submit your departmental application**
- This experience **must** be documented using our “Early Field Experience (EFE) Guide” and submitted with your application to the credential program.
- The Early Field Experience Guide is available for download on the School of Teacher Education website [http://edweb.sdsu.edu/STE/documents/EFE\\_Fall\\_2007.pdf](http://edweb.sdsu.edu/STE/documents/EFE_Fall_2007.pdf) .
- For SDSU Liberal Studies students, who have completed their early field experience as part of ED 200/LS 300, please submit a photocopy of your EFE guide(s) **including your score sheet(s).**

**5. Certificate of Clearance or Emergency Teaching Permit:** Candidates must verify their personal and professional fitness for service in public schools through a state and federal review. This clearance is granted through the California Commission on Teacher Credentialing (see below for contact information). Candidates must submit **ONE** of the following prior to acceptance into the Teacher Credential Program:

- 1) Confirmation of Certificate of Clearance issued by the California Commission on Teacher Credentialing, which must be valid throughout the program and at the time you apply for your credential.
  - To apply for your Certificate of Clearance, please stop by EBA 255 or EBA 259 to pick up a dual LiveScan form and directions for applying for the Certificate of Clearance. If you are out of town, you can call or email our office and request that we mail the form to you (see page 1 for contact info).
  - Carefully follow all instructions for obtaining your Certificate of Clearance, as you will not be admitted without this.
  - This clearance is valid for five years from the date of issuance.
  - Proof of the Certificate of Clearance being granted is posted on the CCTC web site at: <https://teachercred.ctc.ca.gov/teachers/PersonalSearchProxy> Please print the page that shows the document number and issuance date.
- 2) A copy of an original Emergency 30-day Teaching Permit issued by the California Commission on Teacher Credentialing, which must be **valid throughout the program and at the time you apply for your credential.**
  - This clearance is valid for one year from the date of issuance and must be renewed annually.

**6. Personal Narrative:** Please submit 2 copies with your application. The narrative should be double-spaced, typewritten, and no longer than two pages. Type your name in the upper right-hand corner of each page and staple the pages together. The following items should be addressed:

- Your interest in and motivation for a teaching career in a multicultural setting.
- Your personal background/experience in working with children in multicultural settings.
- Other experiences personally considered important in the teacher preparation process.
- Any abilities, knowledge, skills, or experiences that will enhance your effectiveness as a teacher (e.g., ability to speak a second language, play a musical instrument, use technologies, or experience working with individuals with disabilities or special needs)

**7. Letters of Recommendation:** Two letters of recommendation must be submitted from individuals who know you well (but are not related by blood or marriage) and who can comment directly on any of the following:

- Your qualifications for a teaching career
- Your experience in multicultural settings
- Your educational experiences
- Your employment experiences
- Your experiences as a volunteer
- Your experience teaching or supervising students or other groups of individuals
- Your potential for success as a teacher

Both letters should be current, within the last year, and should address your desire to enter a teaching program. Your application will not be considered complete unless both letters are current and signed by the author. The name, address, and phone number of the sender must be included on letterhead stationery or typed on the letter. The signed letters may be hand carried and do not need to be confidential. A variety of types of references will receive a higher score. Letters from people who can speak to the candidate's employment, professional, or educational experiences are preferred and strongly encouraged.

**8. GPA petition:** Candidates who do not meet the 2.67 cumulative or 2.75 in last 60 semester/90 quarter units GPA standard may petition the School of Teacher Education and San Diego State University for special consideration as part of the program application.

- The petitions are contained in the application packet that can be downloaded from our web site.
- Petitions for special consideration for deficiency in grade point average should address factors that may have been contributory to academic performance, as well as skills or abilities in the field of education that may mitigate previous poor academic performance.
- Additional letters of recommendation or professors' statements relative to academic performance in current classes may be attached.
- Submitting the petition in no way guarantees admission to our program or San Diego State University.

**9. Tuberculin Clearance:** Verification of a negative TB test (verification of no presence or active case of TB through PPD or Mantoux test), must be valid and on file throughout the credential program.

- TB tests are valid for four years and can be taken at the SDSU Health Services (for students currently enrolled at SDSU) or through any public health clinic, HMO, or private physician.
- If you receive a positive skin test, then you will need to provide proof that your TB is not active by a doctor's note or x-ray results.

## SUBMITTING YOUR DEPARTMENTAL APPLICATION

The Multiple Subject Teacher Credential Program application must be submitted to the School of Teacher Education office during the official filing period. Applications are available on our web site (see page 1) . There is a \$25.00 application-processing fee for submitting this application.

A complete program application must include the items listed below. Please organize your materials in the order listed below. **Do not submit your materials in a notebook, binder, or portfolio.** Submit copies of all test scores and keep the originals for your records. Incomplete applications will not be accepted, with the exception of pending test scores, letters of recommendation (if being sent directly to our office) and transcripts.

### **Assembling your Application Components (please place in the following order):**

1. **Multiple Subject Credential program departmental application** (please staple all pages together)
2. **Proof of Negative TB test** (please submit a copy; keep the original for your records)
3. **Confirmation of Certificate of Clearance or Emergency Teaching Permit**
4. **CBEST or CSET: Writing Skills test scores** (please submit a copy; keep the original for your records)
5. **CSET scores** (please submit a copy; keep the original for your records)
6. **Transcripts, from all institutions attended** (unless submitted to SDSU directly)
7. **GPA petition** (if necessary)
8. **Personal Narrative (2 copies)**
9. **Two Letters of Recommendation**
10. **Early Field Experience Guide**
11. **Proof of enrollment in prerequisite courses (if needed):** Prerequisite courses (ED 451, MATH 210, HHS 280/TE 296, and SPED 450) cannot be taken concurrently with the program, but may be in progress at the time of application or taken in the summer prior to the fall program. Proof of enrollment in these courses at SDSU or course equivalents at other institutions is required to be considered for admission. Please note that these courses must have been taken in the last 7 years and be a grade of credit, "C" or better.
12. **Proof of completion of U.S. Constitution requirement** (if you have met this requirement prior to application).
13. **Copy of adult/child/infant CPR card (both sides)** (if you have met this requirement prior to application).
14. **Application processing fee:** This application fee of \$25.00 may be paid in person at the SDSU University Cashiers Office (if you have already been assigned a red ID) or may be submitted to the School of Teacher Education as a cashier's check/money order payable to SDSU. *Personal checks and cash will not be accepted by the School of Teacher Education office.*
15. **Block Preference Form:** A completed Block Preference form in which you have numerically ranked your preferences for your block assignment must be submitted with your application. Block offerings vary each semester. Please refer to the School of Teacher Education Multiple Subject Application Packet. Only fill in the box for the term for which you are applying.
16. **Confirmation page from submitting SDSU graduate application**

## ADDITIONAL CREDENTIAL REQUIREMENTS

While not admission requirements, the following must be satisfied prior to obtaining a California Multiple Subject Preliminary Teaching Credential. Candidates who have not satisfied these requirements must take the appropriate coursework or examination before completing the teacher credential program.

1. **Passing the Performance Assessment for California Teachers (PACT)**: This is a performance exercise that you will be working on throughout our program. You will be required to receive a passing score on all parts of this assessment to be eligible for a California credential.
2. **Passing Score on RICA (Reading Instruction Competence Assessment)**: This test is taken during the program after your Reading Methods course.
3. **Completion of a Bachelor's Degree Program**
4. **U.S. Constitution**: All credential candidates are required to verify completion of a collegiate-level course or examination covering the principles and provisions of the United States Constitution. **If you are a California State University (CSU) graduate, you have automatically met this requirement.** Typically this requirement is satisfied by a general education course covering the colonial period of American history (through 1820) or a course covering American government and politics. A grade of credit, "C" or better must be earned. The U.S. Constitution requirement for credentialing purposes may be different from the graduation requirement for the bachelor's degree. The following courses and examinations will meet this U.S. Constitution requirement. This is not an exhaustive list. Contact the School of Teacher Education with questions about other courses.

5. **CPR Training**: Before completion of the credential program, all candidates must have proof on file of current training in cardiopulmonary resuscitation (CPR) that covers infant, child, and adult CPR skills. Training must meet the standards of the American Heart Association (AHA) or the American Red Cross (ARC).
